Industry information – Remedial Massage	Medibank Private, and other private health insurers, have set minimum educational criteria that must be satisfied before they will award a provider number to Remedial Massage Therapists enabling them to offer rebates on private health insurance to eligible clients. The Medibank Private educational criteria require on-campus study for a minimum period of
	12 months, with all clinical training conducted on-campus. Equinim College's HLT52021 Diploma of Remedial Massage course satisfies this requirement. Practical training must be completed on campus as per Equinim College program requirements. To be eligible for a Medibank (or other private health fund) provider number you need to be a member of a professional massage association. International students should check association membership criteria to ensure that you are eligible. You are also required to check and comply with the terms of any visa you are on, as set by the Department of Home Affairs. Refer to our <i>International Student Handbook</i> for further details.
